STATE AND TERRITORY EVENTS

SYMPOSIUM SPONSORED JOINTLY BY AAL AND THE AUSTRALIAN ACADEMY OF SCIENCE

As noted in the last Newsletter, this symposium marks the first collaboration between our Academy and the Australian Academy of Science.

But please note: THERE HAS BEEN A CHANGE OF DATE TO THURSDAY 23 AUGUST 2018

The event will be held in the Federal Court's ceremonial court on Level 21 of the Law Courts Building, Queen's Square, Sydney starting at 5.00 pm.

The topic is: "Are you sure?"

It is likely that there will be some discussion of the following aspects of the topic:

- Scientific certainty compared with legal certainty, and scientific decision-making compared with decision-making by courts;
- The difference between the scientific assessment of evidence and the assessment of evidence by the courts;
- The different notions of what is evidence and the different timeframes for reaching a decision;
- Cause and effect in science and law;
- Unconscious predispositions (biases) of judges and witnesses;
- The presentation and treatment of expert scientific evidence in the courts
- Uncertainty as part of certainty

We are fortunate that The Hon Justice Sarah Derrington has agreed to give a commentary. The Australian Law Reform Commission, of which her Honour is the President, is conducting an inquiry into class action proceedings and third party litigation funders.

As in past years, the event will be held in the Banco Court of the Supreme Court of Queensland.
