### New South Wales

**“World in a Box - 50 years of containerisation in Australia”**



*Overseas Containers Ltd's 'Encounter Bay' - the first international container ship to arrive on the Australian coast - Fremantle, 28th March 1969.*

The first forthcoming event is on Wednesday 23 September 2020 at 5 PM to 6:45 PM.

This is a great opportunity for those who have an interest in the development of container shipping and in the law touching it.

In this online event, you will hear from Martin Orchard, The Hon Justice Angus Stewart, The Hon Justice Sarah Derrington and the chair, The Hon Chief Justice James Allsop AO.

You will see a ten minute extract from a documentary film, *World in a Box – 50 years of containerisation in Australia*, based loosely on the booklet *The Homeward Trade*, written by Martin Orchard in 2006 on a commission from Shipping Australia. It gives an account of the transport of cargo between Australia and UK/Europe from the days of sailing ships to container shipping at the beginning of the 21st Century.

## Patron's Address

The second forthcoming event is the annual Patron's address, to be given on Thursday, 22 October 2020, immediately after the AGM.

This annual address was inaugurated in 2012 when it was given by the Academy of Law's then Patron, Chief Justice Robert French AC. The last two Patron's addresses were given, in 2018, by the then Chief Justice of New Zealand, the Right Honourable Dame Sian Elias GNZM and, in 2019, by the Academy of Law's present Patron, Chief Justice Susan Kiefel AC.

Her Excellency, the Honourable Margaret Beazley AC QC has very kindly agreed to give the address and has chosen as a topic “Aboriginal Australians and the Common Law”.



From its inception, the colony of New South Wales operated under English Law. The initial designation was essentially military, unsurprisingly given the new inhabitants in this very ‘unEnglish’ land. As the colony grew, so did its common law footprint, and so it has remained. What was not and, it may be thought, is still not, settled was the common law's

relationship with the Australians who had been settled on the land for over 60,000 years.

In this brief overview, Her Excellency examines the historical and changing relationship of the Common Law and Australian Aboriginals.

### Recent events

#### Academy of Law/Academy of Science

The two Academies held a Joint Symposium on Wednesday, 19 August 2020 between 5 PM and 6:30 PM. It was an online event

The subject was *The Reception, Quality and Evaluation of Scientific Evidence in Australian Courts*.

The event was open to the public and was a great success. A record of it will be put on the website of each of the Academy of Science and the Academy of Law as soon as possible.

Because of the number of registrants, some 800, it was necessary to use the Academy of Science's technology. In the event there were some 350 participants.

**Donation to AustLII**

At its meeting earlier this month, on 18 August 2020, the Board resolved to make a donation of \$5000 to AustLII which, as Fellows will know, is an institution operated jointly by the Faculties of Law of the University of Technology Sydney and the University of New South Wales. The Board considered that AustLII's public policy purpose, to improve access to justice through access to legal information, supported many of the objects of the Australian Academy of Law. The AAL has not previously contributed to AustLII.

The legislation remains delayed, for reasons having nothing to do with the merits of the AAL's application. I still expect the Bill to be passed but I do not know whether this will be in the August settings.
