### Congratulations

Please join me in congratulating Her Excellency Judge Hilary Charlesworth on her re-election to the International Court of Justice.

Voting took place on 9 November 2023.

The Security Council, meeting independently from but concurrently with the General Assembly, elected five judges to the International Court of Justice beginning on 6 February 2024. The Council re elected Ms Charlesworth (Australia), as well as electing Mr. Aurescu (Romania), Ms. Cleveland (United States), Mr. Verduzco (Mexico) and Mr. Tladi (South Africa).

Her Honour's term will expire on 5 February 2033.



Joint event with the Australasian Institute of Judicial Administration and the Australian Law Journal: *Enduring courts in changing times* 

This 2½ day joint event with the Australian Law Journal (ALJ) and the Australasian Institute of Judicial Administration (AIJA) was held on Friday 8–Sunday 10 September 2023 to mark some important national legal bicentenaries: for New South Wales, the Third Charter of Justice promulgated on 13 October 1823 establishing the Supreme Court and, for Tasmania, the first sitting of the Supreme Court of Van Diemen's Land on 10 May 1824.

We are continuing to examine the feasibility of publishing the entire proceedings.

The Commonwealth AAT and the Tribunal which is intended to replace it

The venue will be Court No 1, Level 8, Federal Court, 305 William Street, Melbourne and online.

We are fortunate that the **Hon Justice Emilios Kyrou AO** has agreed to be our speaker at this event..

Justice Kyrou is the President of the AAT and a judge of the Federal Court of Australia.

From 2008 **Justice Kyrou** was a judge of the Supreme Court of Victoria and from 2014 until his appointment to the Federal Court in 2023 was a Judge of Appeal in that Court.

The Australian Government has announced that a new Administrative Review Tribunal (ART) will replace the Administrative Appeals Tribunal (AAT) and that the ART will be user-focused, efficient, accessible, independent and fair.

The Government has also announced that key features of the legislation to be introduced to the Parliament will include:

- enhanced powers and procedures to enable the ART to respond flexibly to changing caseloads
- a transparent and merit-based selection process for members, informed by the operational needs of the ART
- clear and delineated roles and responsibilities for those who hold leadership positions in the ART, including the President and Registrar
- a simplified membership structure with 4 levels of membership
- greater powers for the President to manage the performance, conduct and professional development of tribunal members
- a user-focused design, including simpler and more consistent application processes, an emphasis on non-adversarial approaches to resolving applications and safeguards to ensure representatives comply with their obligations
- clear mechanisms for the ART to identify, escalate and report on systemic issues in administrative decision-making.

Subject to the passage of legislation through the Parliament, the Government has proposed that the ART will commence operations in 2024.

The commentator will be **Mr Albert Dinelli KC** of the Victorian Bar.

This meeting took the form of a social gathering which included discussion of topics for Michael Coper Roundtables in 2024.



#### Wednesday 22 November 2023, 5.30pm (AEST)

Contempt of Court – A lecture by **Professor David Rolph FAAL** 

This well-attended event was held in the Chief Justice's Courtroom, Courtroom 5, Level 3, Supreme Court of Queensland 415 George Street, Brisbane and online.

**Professor Rolph** is the author of the authoritative work, *Defamation Law*, a consulting editor on *Gatley on Libel and Slander*, and a legal history scholar.



In his lecture he spoke about two major differences between Australia and the United Kingdom in relation to contempt, being the *Contempt of Court Act* 1981 (UK) and the European Convention on Human Rights, which have meant that standard texts

developed for the particular context of the United Kingdom may no longer be appropriate and adapted for Australia.

In addition to those differences, Professor Rolph said it was proper to note some distinguishing features of Australia, which mean that an Australian text on the Australian law of contempt was warranted. One of the issues was the potential impact of aspects of Australian constitutional law on contempt of court, in particular, the potential impact of judicial power under Ch III of the Commonwealth Constitution and the implied freedom of political communication.

Patrick McCafferty KC, a media law specialist, provided a substantive commentary. He concluded by saying that the profession was indebted to Professor Rolph for this fine book.

The Hon Justice Peter Applegarth AM chaired the session. He congratulated Professor Rolph and The Federation Press on publishing this first comprehensive treatment of the Australian law of contempt.

I join Justice Applegarth in thanking **Chief Justice Bowskill** for allowing the AAL to use the Chief Justice's courtroom for this event.
