## Joint event with the Australasian Institute of Judicial Administration and the Australian Law Journal: *Enduring courts in changing times*

This 2<sup>1</sup>/<sub>2</sub> day joint event with the Australian Law Journal (ALJ) and the Australasian Institute of Judicial Administration (AIJA) was held on Friday 8– Sunday 10 September 2023 to mark some important national legal bicentenaries: for New South Wales, the Third Charter of Justice promulgated on 13 October 1823 establishing the Supreme Court and, for Tasmania, the first sitting of the Supreme Court of Van Diemen's Land on 10 May 1824.

The papers are being edited for publication in book form. We are aiming for completion of the book by March/April 2024.

#### Forthcoming events

**18 March 2024 – Melbourne** from 5:00pm – 6:15 pm AEDT

The title of the event is: Mechanisms in the Administrative Review Tribunal Bill to thwart Robodebt-type maladministration

The venue will be Court No 1, Level 8, Federal Court, 305 William Street, Melbourne and online.

We are fortunate that the Hon Justice Emilios Kyrou AO has agreed to be our speaker at this event.. Justice Kyrou is the President of the present AAT and of the proposed Tribunal. He is a judge of the Federal Court of Australia.

From 2008 **Justice Kyrou** was a judge of the Supreme Court of Victoria and from 2014 until his appointment to the Federal Court in 2023 was a

Judge of Appeal in the Supreme Court of Victoria.

The commentator will be **Mr Albert Dinelli KC** of the Victorian Bar.

On 7 December 2023, the Commonwealth Attorney-General introduced into the Federal Parliament the Administrative Review Tribunal Bill 2023 and the Administrative Review Tribunal (Consequential and Transitional Provisions No. 1) Bill 2023. When enacted, the Bills will abolish the Administrative Appeals Tribunal and replace it with the Administrative Review Tribunal. The ART Act will:

- Empower the President to manage the caseloads of the ART in jurisdictional lists and to assign members to jurisdictional areas in accordance with the demands of those caseloads from time to time.
- Provide for a code of conduct and a professional standard for members and facilitate the professional development of members.
- Empower the President to delegate ADR and case management functions to registrars to free members to focus on hearing and determining cases that are not resolved by agreement.
- Provide mechanisms to enable the ART to identify, escalate and report upon systemic issues in administrative decision making, including referring them to a new Guidance and Appeals Panel or to the re-established Administrative Review Council. A key rationale for these mechanisms is to thwart Robodebt-type maladministration.

Justice Kyrou will discuss those mechanisms.

Monday 4 December 2023 – Annual joint event with the Australian Academy of Science (AAS) at The Shine Dome, Canberra

On the joint invitation by the Presidents of the AAS and the AAL, **Dame Julie Maxton DBE** was the guest speaker at our annual joint Academies event(s).

Dame Julie is the Executive Director of the Royal Society, and has held that position since 2011. Before taking up that position, she was Registrar at the University of Oxford, from 2006.

Originally trained as a barrister at the Middle Temple, Dame Julie combined a career as a practising lawyer with that of an academic, holding a number of senior academic positions, including those of Deputy Vice Chancellor, Professor and Dean of the Faculty of Law at the University of Auckland.

She is an Honorary Fellow of University College Oxford, a Bencher of the Middle Temple and a Freeman of the Goldsmith's Company.

This Canberra event was attended by 80 lawyers and scientists who heard a fascinating talk on how the Royal Society is acting to keep bad science out of the courtroom and how best to keep lawyers, especially judges, more up to date with developments in science. **Professor Chennupati Jagadish AC,** President of the Australian Academy of Science introduced Dame Julie and I moved the vote of thanks.
