### **The Hon Margaret Beazley AO appointed as Governor of New South Wales**

All Fellows will have been delighted to have learned of the appointment of Academy Fellow, The Hon Justice Margaret Beazley AO, President of the New South Wales Court of Appeal, as the next Governor of New South Wales.

Her Honour will succeed His Excellency General The Hon David Hurley AC DSC (Ret'd) in that office.

Justice Beazley said that, as Governor, she would be a supporter of education, community and the rule of law, adding: "It is what makes us such a cohesive society".

Justice Beazley will be the second female Governor in the State, after Dame Marie Bashir AC (2001-2014).

It was as recently as 28 November 2018 that Justice Beazley launched the book, *The Future of Australian Legal Education*, sponsored by the Academy and *The Australian Law Journal*.

### **Dr Andrew Bell SC appointed as President of the New South Wales Court of Appeal**
