Professor Auty's lecture was based on her experience in the establishment of Koori courts in Victoria and in Aboriginal sentencing in Kalgoorlie and Norseman in Western Australia. She was able to illustrate the experiences that she recounted by photographs of the indigenous people and the settings involved.

Over refreshments in the foyer of the Court, there was opportunity to ask questions of the speaker.

## Congratulations to Fellows

Congratulations are due to Professors Ros Mason and Ros Croucher.

Ros Mason, Professor of Insolvency Law in the Faculty of Law, Queensland University of Technology, is taking up the position of Chair of the Academics' Group of INSOL International as from 1 January 2015. She succeeds Professor Ian Fletcher in that position and the appointment will be for an initial term of four years.

In the latest quarterly issue of "INSOL World", the journal of INSOL International, it is said in the announcement of Professor Mason's appointment that she "has been a loyal and enthusiastic member of the Academics' Group since its early years and...has regularly presented papers at the colloquiums and has also been instrumental in encouraging younger academics and researchers to join in our meetings and to participate actively."

As is indicated by a later news item in this Newsletter, Ros Mason is also a strong supporter of the Academy.

The Academy congratulates Professor Mason on her taking up the appointment to

this responsible role of leadership at the international level.

In the last week, Professor Rosalind Croucher has been publicly recognized in two ways.

First, it was announced that Rosalind Croucher has been selected as one of *The Australian Financial Review* and Westpac's 100 "Women of Influence" for 2014.

These awards have been made over the last three years in several categories. Professor Croucher, who, as will be well known to Fellows, is President of the Australian Law Reform Commission and Chair of the Academy's Projects Committee, has received this recognition in the "Public Policy" Category.

Second, on Saturday evening 4 October, at their annual conference in Adelaide, the Australian Women Lawyers honoured Rosalind with their award, for which she had been nominated by the New South Wales Women Lawyers.

Members of the Academy extend warm congratulations to Ros Croucher on her receiving these public acknowledgments of her work.

### The 2014 Sydney Peace Prize—Julian Burnside AO QC

It is probably generally known among members of the Academy that Academy Fellow, Julian Burnside, has been selected to receive the 2014 Sydney Peace Prize.

The Prize will be awarded at Sydney Town Hall on Wednesday 5 November at an event scheduled to take place from 7.00 pm to 8.30 pm

This Prize is Australia's only international peace prize and has been awarded for sixteen years to "the most eminent, brave and effective workers for peace throughout the world". Previous recipients have included Archbishop Desmond Tutu, Patrick Dodson, Hans Blix, Sir William Deane AC and Arundhati Roy.

The Sydney Peace Prize Jury's citation in relation to Julian reads:

"For his brave and principled advocacy for human rights and for those wronged by government, for insisting that we respect our international legal obligations toward those seeking asylum, and for his unflinching defence of the rule of law as a means to achieve a more peaceful and just society."

Fellows in Sydney may wish to attend the event on 5 November.

### Launch of the University of New South Wales Law Journal vol 37 No2 2014

This issue of the University of *The New South Wales Law Journal* was launched at the offices of Herbert Smith Freehills in Sydney on the evening of Tuesday 16 September. The significance of the event for the Academy is that it contained an article, "Developments in Court to Court Communications in International Insolvency Cases" by Adjunct Associate Professor Sheryl Jackson and Professor Ros Mason, the research for which was conducted at the initiative of, and with financial support from, the Academy.

Members may recall that at the suggestion of the Council of Chief Justices of Australia and New Zealand, the Academy undertook to inquire into and report upon the implications, if any, for Australia of the report made to the

American Law Institute and the International Insolvency Institute in 2012 by Professor Ian Fletcher of the United Kingdom and Professor Bob Wessels of The Netherlands. The Academy engaged Professor Mason and her colleagues at the Queensland University of Technology to undertake that task on its behalf and, in effect, their report to the Academy became the Academy's report to the Council of Chief Justices.

The article in the Journal acknowledged the role of the Academy. The launch was attended, not only by the authors of the article, but also by the President and Professor David Barker, Secretary of the Academy.

*5.30 pm*—Patron's Address by Chief Justice Menon in the Banco Court of the Supreme Court of New South Wales, Level 13, Law Courts Building, Queen's Square Sydney

*7.00 pm*—Post lecture refreshments in the foyer of the Court.
